

Minutes for the April 9, 2024 Board Meeting

John Hammes property owner of W4469 Gills Coulee Rd West Salem, WI 54669. Parcel #7-1120-7 on 4.48 is requesting a variance for a 60' x 80' pole building. After going out to review the site the board as no issues with approving this request. This does not affect any crop land or neighbors. Supervisor Paul Degenhardt made a motion to approve the 60" x 80' variance, and Supervisor Kevin Hoyer made the second motion. Motion carried.

Rick Carlson from W3136 Old B West Salem, WI 54669 parcel # 7-1142-1 ;7-1142-2 and 7-1171-4 is requesting a variance for a 24' x 64' pole building. After going to look at the site the board determined that it doesn't affect any crop land or any neighbors and has no issues with approval of this variance request. Chairman Blaine Lee made a motion to approve the variance for a 24' x 64' pole building. Supervisor Paul Degenhardt made the second. Motion was carried.

The Town board has no issues with this request and is asking when they are ready to put the driveways in the board needs to review the driveways. Kevin Hoyer made a motion to pay Olympic Builders the requested amount of \$78,704.92. Paul Degenhardt made a second motion. Motion carried.

Recycle Center updates; Town employees are still finding some people are trying to use the recycle center that don't live in the Township. Everything else is going smoothly.

Katie Reding handed out the financial report and the checks written in April. Kevin Hoyer made a motion to accept the financial report. Paul Degenhardt made the second motion. Motion carried.

Pay the bills; Paul Degenhardt made a motion to pay the bills. Kevin Hoyer made the second. Motion carried.

Kevin Hoyer made a motion to adjourn the meeting at 9:35pm. Paul Degenhardt made the second. Motion carried.
